Core user task

After conducting interviews, our group realized that people are more likely to have a productive conversation among friends since people are less likely to attack or insult their friends even if their friends disagree with them. Our group came up with a website which allows a group of users, who are friends with each other to take a poll on controversial political and social topics of their own interest. At the end of the poll, users can see the friends who have different opinions from theirs and start a conversation on this topic.

Study measures

- Study Procedure:
 - 1. A group member will provide the participant with a brief introduction regarding the background of our application, purpose of conducting this study, and the core user task that we hope to achieve.
 - 2. Ask the participants to sign on the Informed Consent Form and also explain some of the most important factors in the form. We will ensure that they are free to stop and leave from the study whenever they feel uncomfortable and they do not have to answer any question they do not want to.
 - 3. Since it is more difficult to find two friends to participate in study at the same time, one of our group member will act for the role of his/her friend as he/she go through the process of the study.
 - 4. We will show them the home page of the application and allow them to explore the application themselves, they are free to ask questions at any time during the study.
 - 5. Our group members will record the time they used throughout the whole process of study. We will also keep track of any steps where the user spent a long time understanding the functionalities and record all the questions they asked during the study.
 - 6. After using the application, we will ask they a couple of interview questions to further understand what part of the application was especially strong and what part needed further improvements.

- 2. Which part during using the application did it take them longer than others?

o Errors:

- 1. What mistakes did the user make while they were using the application and did we do a good job at preventing and recovering from errors.
- 2. What part during the application that user didn't do what we intended?

• What was an aspect during the experience using the app that you found especially pleasant?

I like the idea that each conversation is actually temporary saved, so I don't need to worry about privacy or safety issues, especially during this social media explosion era, I like to keep more conversation in private.

• What was a part of the application that you found especially confusing?

When I click the person's name that I want to talk to, instead of directing me to the conversation with that person, it took me back to the BeginPoll interface, which is very confusing and doesn't make any sense.

Name should be unique otherwise it could confuse users.

• What aesthetic issues do you see when you go over the process?

Message bar moves as I type more messages instead of being static at the same place, as what I used to in other media.

Reflection:

What worked well:

- The application only shows the person's name who has different opinions for a controversial topic. This helps facilitate the conversation against different opinions.
- Our group member gave them clear explanations of what they should do at a specific stage whenever the participants got stuck.

What needs improvement:

- We should explain the background a little bit better to the participants. They were sometime confused of who are they actually talking to and whether the conversation is anonymous.
- The interview process was a little bit disorganized since we were throwing a lot of random questions at the participants. It would be better if we came up with a survey for them to fill out instead. It would also be easier for us to collect and analyze data when the number of people participate in the study grows larger.
- Could ask questions that gathers more quantitative data instead of throwing too much qualitative questions.
